 - (I) update on defibrillators

(ii) Update on broadband

The wayleaves have been concluded for connections through the Duntisbournes:- Waines Road then Itlay. All is planned to be completed by the end of August.

(iii) Update on speed-watch

Natalie and Cllr Elliott are the only trained people at the moment. If there is anyone interested in being trained please contact Cllr Elliott.

Parishioner concerned that the village is being used as a 'rat run' following the re-design of Cirencester town centre access roads. Cllr Elliott to complete speed survey and follow up with Andrea Shutt regarding the monitoring of vehicular traffic through the village.

(iv) Update on Highways matters

The silt trap at the bottom of Maces Hill has still not been cleared despite an e mail exchange with Highways.

The Chairman reported receiving an apology from Amey for not pursuing the maintenance of the width of the bridle path behind Grove Hill cottages, with an assurance that the matter would be followed up with GCC Legal Department.

Pot-hole survey completed by Cllr Elliott and Clerk to identify extent of road damage and potential hazards caused by the poor condition of some of the Village's main roads. An annotated map of

location and severity of damage was produced. It was clear that Overley Road and Dowers Lane were particularly bad. The survey will be repeated before each PC meeting so that monitoring and reporting can take place. This information is to be communicated to Highways – Richard Gray, Julie Phelps(Cotswold.gov.uk) and Nigel Robbins(Cirencester Mayor)
