Matters arising from minutes.

(i) Update on Highways matters.

Some potholes have been repaired and it seems to a much higher standard than before.

Silt traps were cleared but the silt was piled up against parishioner's wall at the bottom of Maces Hill. This was only removed after repeated requests from PC. Trap at Itlay to be checked.

High Path issues

- (v)Speeding in Lower End: A letter has been sent to Stables owner reminding that the road goes through a residential area with children playing but drivers are still travelling too fast. This has been forwarded to all clients of the stables

The idea was to honour those parishioners who served in WW II. After much discussion it was felt that the PC would endorse a special time for reflection and celebration possibly at the Village Barbecue if there were survivors or descendants within the village. The PC will revisit this topic in the light of John Symond's research.

- Replacing memorial plaque for Haines Family damaged by mower.
